This system has been designed to accommodate the requirement for an easy to install and remove system that turns your everyday Defender into a comfortable, ergonomical and functional camper whilst being able to keep in your middle row seats for passengers – great for family adventures.

Turn your Defender into a camper in less than 30 minutes

Ready to sleep or travel in seconds

And back into your everyday vehicle in less than

Made in the UK with 12mm quality Birch Ply and quality fittings and fixtures (requires empty cargo area, 60/40 low back seat spec - pre-Puma)





#### KEEP IN YOUR MIDDLE ROW SEATS

This is one of the key reasons this system is so versatile and unique.

If you have the original 60/40 low back seats, this system will work in a number of ways –

- All 3 seats in use
- The 60 split (2 seats)
- The 40 split (1 seat)
- Or, seats folded (none used)

Even if you have no seats in place, Kenshatori is developing an additional storage system as an optional extra to The Weekender system that will drop into the middle row footwell giving you many more options





#### THE TALL BOY


The Tall Boy is the leading unit. It can be used on either side with a single hinge change, but it's best to decide before you order.

The unit sits on either rear wheel arch and provides an estimated 192+ litres of storage space between six compartment spaces. The unit can be used as part of the system or as a stand-alone unit – you could even have two Tall Boys – one on either side if you wanted to.

At the top, there is a stuff shelf that's great for stuffing in hats, gloves and High Visibility vest etc.

The top 2 cabinets have been specially designed to hold canned goods but can be used for anything that fits. The doors make great shelves at night for a water glass or for somewhere to keep your smaller items close by.

The two larger compartments sit at window height and give a whopping 48 litres each of storage. There's an inside shelf included too that's height adjustable and also a removable left or right side compartment ideal for a single gas burner stove. The dropdown doors also act as nice eating or laptop tables.





#### THE TALL BOY

The bottom wheel arch door is split so you can still access the area even when the bed is set up.

The Tall boy comes with a single frame strip for you to attach the hinge to, should you wish to use as a stand-alone unit with a drawer system for example.

All of the top 4 doors have adjustable and removable steel cable stays and all doors use a simple no frills slam latch, keeping the exterior latch free for a clean line look.





#### THE STUBBY BOX

The Stubby Box is the secondary unit. It can be used on either side as part of the system or as a stand-alone unit. You could even have two Stubby Boxes – one on either side if you wanted to.

The unit sits on either rear wheel arch and provides 21+ litres of storage, not including what is beyond that of the unit in the side panel space of the wheel arch – accessed by the dropdown side doors. A great place with easy access to all your hand tools etc.

Not only does the Stubby Box provide storage, but also it forms part of the spacious sleeping area and is the primary place to keep your bed panels secure and out of the way whilst still allowing easy access to them when setting up for the night. Once the bed panels are removed, you now have a small shelf to use too.

All doors have magnetic stays to make life easier and rattle free.



# FRIDGE BOX

GENERAL STORES BOX ?

#### THE FRIDGE BOX

The Fridge box has been designed to securely house the Alpicool D30 Adventurer 20 litre compressor fridge (not included). The design of the box allows you to access the pull drawer fridge from the inside or from the outside with or without the bed in use.

So as not to waste any space, above the fridge sits a handy 50mm high storage tray – great for all your smaller bits and pieces.


When the fridge is not in use, there's also 45 litres of open storage at the front (fridge door end). A great place for your footwear, or to use a tub or bag stow.


The unit is also part of your seating and sleeping arrangement.
















#### THE GENERAL STORES BOX

If you're not intending to use a slide fridge, The General Stores Box is a huge storage solution with a whopping 120+ litres of space.

The box is divided into two main compartments to add strength to the seating and sleeping platform and comes with four removable dividers that help with compartmentalising your gear.

It's probably a two-person lift, but the box can be removed with your gear still inside, making it easier to store things in one place at home.



# THE FLOOR SYSTEM F THE T-PIECE

The Floor System form part of the Weekender's foundation. It does not need to be bolted to the floor – instead it uses a castle type locking function that works in conjunction with the Tall Boy and Stubby Box units. This combination of fitment allows the Floor System to stay in place.

The Floor System can accommodate both the Fridge Box and General Stores Box, on either side of which are anchor points for the Head End options.

In addition to the Floor System is the T-Piece. The T-piece is an optional piece of floor that lays beneath the middle row seats and attaches to the Floor System to hold it in place.

This addition not only tidies up the area under your seat but is also a fantastic solution for fixing items like Sub Woofers or Inverters for example without having to drill holes into your vehicle's floor.

Another great feature is the seat bar slots: if you have tired seat bar hinges these may well help keep that 60/40 seat split a little better looking too!

#### THE HEAD END

The Head End is the foremost part of the sleeping platform and simply hinges up and locks into place with the supplied brackets and bungee cords when your seats are required. When the Head End is down, there is a cavern of potential storage below.

The Head End comes in three options:

- A single piece
- A 60/40 split
- A three-way split (as shown)

All three options are available with or without the Rearview Flap – a great option if you still want to use your rearview mirror or if you need to grab something in the rear from the middle row seat.

















#### THE BED PANELS

The Bed Panels are the last piece of the puzzle and complete the sleeping platform.

These removable panels can be stored in two locations when not in use – locked into the Floor System or locked into the Stubby Box shelf.

The latter is the best solution. Not only does this avoid the panels being potentially scratched from foot traffic if stored on the floor but also storing them in this way provides a back rest when you are using the seating area. Furthermore, the panels will provide privacy on the inside from the outside.

Each bed panel has a rn embedded in steel plate allowing it to be magnetically secured in its lying position or upright stored position (window frame adhesive magnets are supplied).



#### INSTALLING YOUR WEEKENDER

For most Defender owners setting up and installing the Weekender system should take less than 30 minutes and less than 10 minutes to take it all out again. For the first set up some basic DIY skills may be necessary.

The system has been designed to use existing fixtures in the Defender to secure it. However, being a Defender, there could be some differences from vehicle to vehicle, but if required these will be easy fixes via some minor alterations to your vehicle or to the system.

The Tall Boy is designed to be a snug fit between the original carpet and headliner – but there is enough flexibility built into the design to overcome any challenges.

To install the system all you will need is the supplied Hexi/Allen key, but when using for the first time you may need some other tools in case you have to make any adjustments as noted above.

There are a few different ways to secure the Tall Boy and Stubby Box:

- via the cargo area seat back mounts
- via the wheel arch seat base mounting holes
- via the internal roof rail (Tall Boy only)

Other tools that may be required for installation:

- A drill and drill bits (metal & wood), metal file/sanding paper
- A tape measure and marking pen/pencil
- 17mm spanner (for the seat belt mounting bracket)
- Riv-Nut tool with 6mm Riv-Nuts



- o you inform us of your intention to return the goods within 14 days of receipt of the goods.
- o you return the goods at your own cost to our warehouse address.
- o you return the goods unopened and undamaged in their original undamaged packaging.
- you have not damaged any original packaging

#### **Notes**

- Refunds will be issued within 14 days for goods returned in perfect order
  - We reserve the right to make deductions from your refund to cover any expense we may have occurred during the transaction. This could be as a result of any of the following:
    - o The goods are returned by the carrier because no one was available to accept the order
    - o The goods are returned by the carrier because the delivery was refused by the recipient

#### **DAMAGED GOODS**

When your goods leave our warehouse facility they will be documented as being in perfect order and we and the carrier will sign to this fact, and the carrier must show you this document upon delivery. In the unlikely event your goods are received damaged from transit, you must sign for them as DAMAGED and report this to the carrier upon receipt.

Alternatively, should the carrier not be willing to wait for you to check the condition of the goods, you must let us know within 1 hour of receipt that they are damaged in order to be eligible for a replacement or refund.

#### RIGHTS OF CANCELLATION
